MINUTES FOR THE TOWN OF SPRING GROVE
MAY 9, 2017
HELD AT QUAKER HILL
7:00 PM

BOARD MEMBERS PRESENT INCLUDED MR. WERNER, MR. CLARK, AND MR. LUKACEK. ALSO IN ATTENDANCE WERE CAROL POLVER, A.J. SICKMAN, JEFF CAPP, ANNAMARIE CHASTEEN, AND JOE KAISER.

THE MINUTES OF THE APRIL WERE READ AND TWO CORRECTIONS WERE MADE, AND NOTED BY MR. WERNER, WHO PRESIDED.

SHERIFF JEFF CAPP APPEARED BEFORE THE BOARD AND REVIEWED NUMEROUS STATISTICS REGARDING CITATIONS MADE BY HIS OFFICERS ON WATERFALL ROAD, INCLUDING 63 ARRESTS FOR SPEEDING, PLUS WARNINGS, CITATIONS FOR HAVING SUSPENDED LICENSES, DISOBEYING POSTED SIGNS, AND OPERATING A VEHICLE WITHOUT A LICENSE.

MR. WERNER RAISED THE QUESTION OF ZERO TOLERANCE, BUT SHERIFF CAPP SAID THAT ENFORCING ZERO TOLERANCE IS IMPOSSIBLE AND WILL NOT BECOME A REALITY. MR. WERNER SAID THAT THE BOARD DID NOT FEEL IT WAS GETTING A SUBSTANTIAL ENOUGH RETURN FOR THE MONEY THE TOWN IS SPENDING ON HAVING ADDITIONAL PROTECTION ON WATERFALL ROAD. A LENGTHY DISCUSSION FOLLOWED REGARDING SPEED LIMITS AND CITATIONS FOR OTHER REASONS.

THE DEFINITION OF LAW ENFORCEMENT TERMS WAS ALSO DISCUSSED. AT THE CONCLUSION IT WAS AGREED THAT THE BOARD AND THE SHERIFF NEEDED TO HAVE FURTHER COMMUNICATION.

MR. LUKACEK ANNOUNCED HE HAD RECEIVED ONE ESTIMATE FOR A TRAFFIC STUDY BY AN ENGINEERING COMPANY REGARDING SPEED HUMPS.

AGENDA ITEMS DEFERRED UNTIL A LATER MEETING INCLUDED THE AUDIT'S EXIT CONFERENCE AND THE MILESTONE BID FOR WORK ON LINDA LANE. MR. WERNER ANNOUNCED THAT GORDON MOORE, SURVEYOR, WAS IN THE PROCESS OF COMPLETING HIS WORK FOR THE EXTENSION TO THE TRAIL.

MR. LUKACEK GAVE AN UPDATE ON THE PLAN COMMISSIONS PROGRESS IN UJPDATING THE COMMISSION'S ORDINANCES.

AT 8:32 MR. WERNER MOVED, SECONDED BY MR. CLARK, THAT THE MEETING BE ADJOURNED. UNANIMOUS.
